





TR ISTANBU07:

Incoming Erasmus applications are reviewed by a teaching committee who decide upon acceptance of student's mobility project based on portfolio, CV and covering letter. The total number of incoming students who are accepted each term is limited.

A GRAZ09:

Incoming students: If students apply within the given application deadline, they are provided with the following services:

- assistance with accommodation
- buddy system
- academic advising by international coordinators at our institutes/degree programmes
- Orientation programme before the semesters starts
- German as a Foreign language (Intensive course before the semester starts and semester courses) and culture courses

2. The **receiving institution** will send its decision within **4 weeks**.
3. A **Transcript of Records** will be issued by the receiving institution **no later than 5 weeks** after the assessment period has finished at the receiving HEI.

4. Termination of the agreement

In the event of unilateral termination, a notice of at least **one academic year** should be given. This means that a unilateral decision to discontinue the exchanges notified to the other party by 1 September 20XX will only take effect as of 1 September 20XX+1. Neither the European Commission nor the National Agencies can be held responsible in case of a conflict.


