4. Termination of the agreement

*[It is up to the involved institutions to agree on the procedure for modifying or terminating the inter-institutional agreement. The termination clauses must include the following disclaimer: "Neither the European Commission nor the National Agencies can be held responsible in case of a conflict."]*

## F. Information

### 1. Grading systems of the institutions

*FNANCY38: In the Nancy School of Architecture system, each course unit is graded on a scale from 0 to 20 points. When a student does not take the corresponding examination or final assessment, this is reflected as absent. To pass a course unit, a student must receive a grade of at least 10 out of 20 points.*

The table will facilitate the interpretation of each grade awarded to students and will facilitate the credit transfer by the sending institution.]*

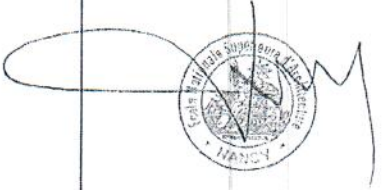
