- Exchange students should be nominated by the home institution
- Incoming students will be accepted on the basis of their audition/recording, motivation statement, and available staff resources each time. Admission letter will be sent by Email to the student and his/her home institution's contact person.
- Incoming students are admitted as full-time, non-graduating students.
- The sending institution should inform the receiving institution, previous to the exchange, about any disabilities to ensure that relevant support can be put in place.

2. The receiving institution will send its decision within [4] weeks.
3. A Transcript of Records will be issued by the receiving institution no later than [4] weeks after the assessment period has finished at the receiving HEI. *[It should normally not exceed five weeks according to the Erasmus Charter for Higher Education guidelines]*
4. Termination of the agreement

[It is up to the involved institutions to agree on the procedure for modifying or terminating the inter-institutional agreement. However, in the event of unilateral termination, a notice of at least one academic year should be given. This means that a unilateral decision to discontinue the exchanges notified to the other party by 1 September 20XX will only take effect as of 1 September 20XX+1. The termination clauses must include the following disclaimer: "Neither the European Commission nor the National Agencies can be held responsible in case of a conflict."]


